

# WEB SEMINAR REGISTRATION FORM

**Early registration discounted fee (for registration received by February 21):** \$250 for the first web connection; \$185 for the second connection; \$125 for the third connection; and \$60 for each subsequent connection.

**Regular Fee (for registration received after February 21):** \$265 for the first web connection; \$195 for the second connection; \$130 for the third connection; and \$65 for each subsequent connection.

All attendees, irrespective of the number of registered sites, can earn 0.2 Continuing Education Units (CEUs) or 2.0 professional development hours (PDHs). CEU/PDH certificates are included in the registration.
